# **OFFICER'S REPORTS**

### THE SOCIETY

#### 2011

2011 was dominated by the Society's concerns for the future of archaeology and heritage in Buckinghamshire, in the form of HS2 and the County Council spending review. On both these issues Council was active in lending support to our colleagues in the museum and archaeology departments, and in lobbying various individuals and bodies. The Historic Buildings' Group took an equally active role by carrying out a historical impact assessment in the villages of Twyford and Chetwode, highlighting the potential threat which HS2 will be to our local heritage. This work will continue in 2012 with the unsurprising announcement of the scheme's go-ahead. Council was pleased that the immediate future of the County Museum has been secured and that work is progressing to create a Trust which will be instrumental in taking the museum forward on a sound financial footing.

Work started on the redrafting of the Society's Constitution, led by Mike Farley. The need for change was identified in 2010 for two primary reasons: as a response to changes in local government responsibilities, now dispersed to seven separate bodies, and in order to clarify the structure of governance within the Society, particularly as regards the status of trustees. This process proved to require a great deal of attention to detail and to the legal implications of any changes, but it is hoped that the new Constitution will be accepted by the membership at the 2012 Annual General Meeting.

The Historic Buildings' Group continued its work on a number of projects including an extensive village survey in Great Horwood, which was preceded by a very well attended study day, involving a number of local residents. The entire conservation area of the village was surveyed house by house, and more detailed surveys of individual houses of historical interest are planned for 2012. Peter Marsden continued to work hard on the digitisation of *Records of Buckinghamshire* for the Society's website. Alongside Kevin Quick, Peter has kept the website up to date and given it renewed relevance, accessibility and appeal.

This year's Buckinghamshire Local History Network Conference in October took for its theme "Military Buckinghamshire", with presentations on moats, mottes and castles, the Civil and First World Wars, Bletchley Park and portraits of Buckinghamshire military men, amongst others. As in previous years, this event was well organised and attracted a large number of participants.

Four council meetings were held during the year: January 8<sup>th</sup>, March 19<sup>th</sup>, June 4<sup>th</sup> and October 15<sup>th</sup>, with the AGM being held on 7<sup>th</sup> May 2011.

At the March Council meeting, Professor John Clarke's resignation from his position as Honorary Editor of *Records of Bucks* was announced. John took over as Editor in 2001 and was responsible for volumes 42 to 51, during which period *Records* went strength to strength. John's increasingly pressing university commitments in Buckingham forced his resignation. The Society is extremely grateful for the time and effort John put into his role as Editor for so many years. John Broad was nominated to the post of Honorary Editor at the AGM. John is the Chair of the Bucks Records Society and was a lecturer at the London Metropolitan University before his retirement.

At the June Council meeting, Peter Marsden was unanimously elected as Chair of Council, following Mike Farley's retirement from the post. Peter subsequently proved himself to have a flair for the role and has conducted the meetings with efficiency and diplomacy, following Mike's excellent example.

Marian Miller's term of office on Council was completed this year. Her replacement, Karen Pepler, has been an active member of the Historic Buildings' Group and will act as representative for that group on Council. Although Marian is no longer serving on Council, the Society is delighted that her sterling work on HS2 will continue.

Our Honorary Treasurer Nicola Savage also resigned from post this year. Nicola has worked extremely hard during her term of office, in a most efficient and approachable manner. Finding a replacement for Nicola proved difficult, but Graham Parker stepped into the breach at the end of the year and Council looks forward to working with Graham in 2012 and beyond. 2011 saw a great number of changes for the Society and undoubtedly 2012 will prove likewise. Public purse strings remain firmly tightened, reorganisations continue apace and the impending shadow of HS2 hangs over our beautiful county. As a Society charged with an interest in the protection and promotion of our heritage in all its forms, it is vital that we each take an active role in its future enterprises. We can all make a contribution, whether by giving our time, expertise, encouragement or support. In this way we will keep the Society vibrant for many years to come.

# **ON-LINE ACTIVITIES**

### THE SOCIETY'S WEBSITE

The Society's website – www.bucksas.org.uk – has become an important part of its public profile, displaying both advance information about society activities and reports on the results of members' endeavours. The website is available to members and non-members.

During 2011 and 2012 the most important additions to the website have been linked to the government's plans to build a new high-speed rail line, 'HS2', across Buckinghamshire from Denham in the south to Chetwode in the north. These include impact assessment surveys along the route, covering historic buildings, landscapes and earthworks. Survey reports were added to the website in 2011 on the village, earthworks and former manor house at Twyford, on Potter Row in the Chilterns and Chetwode in North Bucks. In 2012 these were joined by the deserted village site at Stoke Mandeville, Road Barn Farm near Wendover, and earthworks on the Doddershall estate near Quainton.

Other recent additions include an external survey of all buildings in the Conservation Area at Great Horwood (118 buildings of all historical periods) and the Bucks Historic Pubs Survey, which by the end of 2012 had recorded 115 pubs and former pubs across the county.

The website also includes a full listing of all the articles that have been published in *Records* since the first volume was published in 1858, enabling members and non-members to obtain both *Records* back numbers and offprints of individual articles. The website also provides access to out-of-print back numbers of *Records*, which are gradually being made available on-line.

#### Records of Buckinghamshire On-Line

Two back numbers of *Records* are available on-line through the society's website: volume 11 from the early 1920s and volume 17 from the 1960s. This is part of an active project which will see the long out-of-print volume 1 made available on-line during 2013.

The two on-line volumes have made re-available over fifty articles on a wide range of topics, including the Buckinghamshire Oath Rolls, Aylesbury's Charter, Tickford Priory, the building of Winslow Hall, the Penn Doom, Railways and the growth of Wolverton.

The publication of articles in *Records* requires authors to assign copyright to the society, though the society will permit authors to reproduce their work elsewhere. The society is a charity: its publications, printed and on-line, are for public benefit, not financial gain. In the past, copyright did not cover on-line publication, as the world-wide web had not yet been invented. For this project, the society has therefore made reasonable attempts to notify all past authors (or their executors), to elicit agreement or objection to placing their work online. So that the project may proceed, in the absence of an objection the society will assume that permission has been given.
